

RECORDS OF THE BAPTIZED CHURCH OF CHRIST, IN VESPER.

Commencing with brief introductory remarks showing the origin of the cause of Christ in this place and the cause leading to the present organization.

Up to 1815 there had been no religious meetings established nor church organized in Tully. In June of that year Eld. Enos Smith from Massachusetts came into the place and labored a voluntary missionary in Tully and Spafford about four weeks. When about to leave he expressed deep anxiety that religious meetings should be established, he finally obtained the assent of Br. Uriel Smith & wife & Br. Riba Parmer, the former member of the Baptist Church in Truxton, the latter in Marcellus, who trusting in God, engaged to establish meetings for the worship of God on the first day of the week, commencing the next Sabbath at the house of Br. Smith, trusting in the promises and Grace of God, to enable them to fulfill their engagement and hereafter maintain the public worship of God in the place, there being then no other professing faith in Christ known in the place to join them.

They accordingly met the next Sabbath at the house of Br. Smith, much (much) to the joy of their _____ for the Lord Jesus by his spirit was with them to bless and they were strengthened and encouraged for the Spirit of God moved upon the hearts of the people around, so that the third Sabbath the house was filled at an early hour, and the Holy Spirit's influence was richly felt. Some were _____ in the heart conviction for sin rested upon them, and soon after a number were hopefully converted to God. Eld. Alfred Bennett of Homer being applied too, came and preached and baptized a number of times during the fall and winter following. The Good Lord still continued to bless the _____ instrumentality at the beginning, until their numbers increased to the five males & nine females, who covenanted together to maintain the worship of God and His ordinances as a church if they can be fellowshipped as such by the Sister Churches around. Having taken the preliminary steps, adopted their articles of faith and covenant, sent letters of invitation to the following churches. (to wit) Homer, Truxton, Fabius and Pompey, to meet at the house of Br. U. Smith's the 28th of Feb. 1816. Agreeable to appointment the church or conference met at the place afore said, having previously chosen Br. U. Smith to represent them to the council. The churches sent to were represented as follows: Homer, Eld. Alfred Bennett, Dea. Thomas Collier, Brethren Salsbury & Green - Truxton, Eld. T. Purrington, Brethren Uriah Smith, John Bautwell - Pompey & Fabius Dea. White Osborn, & Calvin Peck, Br. R. Chase. Organized by choice of Eld. Alfred Bennett, moderator & R. Chase, Clerk. The result, fellowship was given to them as a Sister Church of Christ.. The Lord still blessed so that their chords were lengthened, converts were multiplied and their territory extended over the whole town.

In 1824 they agreed on a local contract at the center of the Town and built a meeting house, where they continued to worship until Dec. 1847 when it became a subject of prayerful deliberation with regard to the locality of the meeting house, the village east increasing in population, and Vesper west a little growing village where the church first originated & the sparseness of the population at the center and also the intermediate space between the two villages, it was thought by some, it would be for the interest of the Redeemers Kingdom to vacate the present location and remove the meeting house to the village east, and establish another permanent local center at Vesper west. After mature and prayerful deliberation at a church meeting, Dec. 9th, 1847 it was resolved the meeting house might be removed to the village east and that when so removed, the Parsonage, so called, be sold or disposed of and the avails thereof be appropriated to the building of a Baptist meeting house at Vesper.

About this time the Lord seemed to move upon the hearts of the people, and they said, let us arise and build. Accordingly meetings were held and a religious society was organized to be known and distinguished as the Baptist Religious Society of Vesper. A site fixed and agreed upon and proper measures entered into for to build a meeting house the coming season. Accordingly the work went on, and the house went up, and was in a forward way of being finished. Thereupon after having several informal meetings for prayer and consultation with regard to raising a new standard and organizing a separate and independent Baptist Church of Christ at Vesper, to be publicly recognized at the dedication of their new meeting house, were of unanimous opinion that it would be for the Glory of God and the advancement of the Redeemers Kingdom, and that His providence and grace had clearly pointed to this result. Whereupon the Baptist Church in Tully was consulted with, and leave asked for a number of Brethren and Sisters to be dismissed for this object. Whereupon at a church meeting of the Baptist Church in Tully, Dec. 9th, 1848, it was unanimously resolved that Letters of Dismission and Commendation be given to the following Brethren & Sisters for the special purpose with our fellowship to form themselves into a separate church at Vesper.

At a meeting of the Brethren & Sisters of Vesper, being duly notified for the express purpose of organizing themselves and becoming a Baptized Church of Christ in Vesper, held at the house of Dea. Josiah Daniels, Dec. 30th 1848. Meeting opened by reading the Scriptures and prayer.

1. Resolved that Br. Uriel Smith serve as Chairman.
2. Resolved the Br. Allen Parmer serve as Clerk.
 Eld. Alfred Bennett being present was invited to take a seat and act and council with us in our deliberations. Accepted.
3. Resolved that we form ourselves into a religious body to be known as the Baptist Church of Christ in Vesper if it is thought proper by a council from sister churches to fellowship us as such .
4. Resolved that we adopt the Articles of Faith and Covenant as published by the Onondaga Baptist Association as our Articles of Faith & Covenant.
5. Resolved that the 18th day of January 1849, be the day for opening and dedicating our new meeting house for the worship and service of God.
6. Resolved that we invite Eld. Alfred Bennett to preach the dedication sermon.
7. Resolved that we send for the following churches to sit with us in council at 2 o'clock P.M. on the same day of the dedication and if thought proper to give us fellowship as a sister church. (Viz.) Fabius, Spafford, Marcellus, 2nd Onondage and Tully.
8. Resolved that Brethren Uriel Smith, Allen Parmer & Josiah Daniels be a committee to represent us to the council on that day.
9. Resolved that Br. J. Daniels receive the right hand of fellowship in behalf of the church if tendered.
10. Resolved that the clerk be authorized and required to write letters of invitation to the above named churches.

1849

Jan. 18, 1849

The new meeting house opened at 19 o'clock A.M. Eld. Alfred Bennett preached the dedication sermon. 2 o'clock P.M. council convened. Prayer by Eld. W. G. Dye - Organized by choosing Eld. N. Camp moderator and Elder A. R. Parmer clerk. The churches invited were then called upon, of which the following were represented. (viz.) Fabius, Eld. W. G. Dye, Dea. F. Clark & John Clough. Spafford, Eld. Benjamin Andrews, Eld. A. Boughton, Dea. Aaron Van Antwerp, Br. Silas Randel, W. G. Parmer & A. M. Rounday. 2nd Onondaga, Eld. B. Capron, Eld. G. T. Gardner, Dea. S. Kinyon, L. Gardner, S. Bedel, James Rowe Jr. & A. Cummings. Tully, Eld. N. Camp, Dea J. Out, Br. S. S. Carpenter, W. T. Tallman, O. D. Parmer & D. Vail. Delegates of the Brethren & Sisters of Vesper, Dea. U. Smith, Dea. J. Daniels, and Br. A. Parmer.

Persuant to invitation the following Brethren took their seats with the council. (Viz.) Eld. Alfred Bennett, Eld. Asa Colwell, Eld. A. R. Parmer, Br. R. R. Hoxie & A. P. Clerk.

The doings of the Brethren & Sisters of Vesper & vicinity were presented by Dea. U. Smith,

relative to forming a separate church organization & heard an inquiry was made respecting their design in leaving the church in Tully; their Articles of Faith and Covenant, their numbers etc. Whereupon the council being satisfied unanimously resolved to give them fellowship as a Baptist Church of Christ in Vesper, which was done on the following day at 10 o'clock A. M. as follows. -- Order of exercises:

At 10 o'clock A.M. Jan. 19, 1849.

Sermon by Eld. W. G. Dye from Romans 12:9.

Eld N. Camp gave the hand of fellowship.

Eld. Alfred Bennett addressed the newly recognized church after which the council adjourned

Jan. 21, 1849 Sabbath

At the close of service motion by Br. U. Smith, Resolved there be a meeting of the church in the session room the 26th at 1 o'clock P.M. to attend to and do the business necessary for the further regulation, order and future labor of the church.

Jan. 26, 1849

Church met agreeable to appointment. Opened by prayer by Br. E. V. P. French.

1. Resolved that Elder N. Camp be invited to take part in our deliberations and serve the church as chairman of this meeting. Accepted.
 2. Resolved that Br. U. Smith serve as clerk, the ensuing year, and that he be instructed to purchase a suitable book, in which to keep the records.
 3. Resolved that Josiah Daniels serve as treasurer.
 4. Resolved that David Williams serve as sexton.
 5. Resolved that we make choice of two Brethren to serve as Deacons.
 6. Resolved that Brethren Urial Smith & Josiah Daniels serve as Deacons.
 7. Resolved that our covenant (covenant) meeting be held the Saturday preceeding the 2nd Sabbath in each and every month and that our communion seasons or the time for administering (administering) the Lords Supper be the Sabbath following every other month beginning the 2nd Sabbath in February next.
 8. Resolved that we take up a contribution the first Sabbath in each and every month to defray the necessary expenses of the house such as cleaning, furnishing fuel, light, etc.
 9. Resolved that we create a fund by contribution to be put in the hands of the Deacons for to defray the expenses of the Lords Table, and the relief of the poor, and it be the duty of every male member to contribute at least 12 ½ and the females 6 cents per year for this object.
 10. Resolved that our Articles of Faith and Covenant be read at the opening of each covenant meeting after prayer.
 11. Resolved that our next annual meeting be held the first Tuesday in Feb., 1850 at 1 o'clock P.M. at the meeting house.
- Agreed to that time and place. Prayer by the chairman.
Surely we could all say God has been our helper. In Him will we trust.

Feb. 10, 1849 Saturday

Covenant meeting agreeable to appointment attended. Opened by prayer, after which the Articles of Faith and Covenant was read by Deacon U. Smith. Then a period season of conference and mutual interchange of feeling was enjoyed, and the way seemed clear to go forward to the ordinance of the Supper. We could cheerfully sing with the poet, "Oh, for an overcoming faith" to speed us on the way. Closed by prayer. 23 present.

Feb. 11, 1849 Sunday

Elder Thomas Brown preached and administered the Lords Supper. The burst of feeling seemed (seemed) to be breathed forth, "Why was I made to hear thy voice and enter while there room. Present 26 and some visiting Br. & Sisters.

Mar. 11, 1849 Saturday

Monthly covenant meeting attended. After the usual time occupied in Brethren & Sisters expressing their feelings, love and harmony prevailing. Took up the subject of giving Elder Thomas Brown

a call to be our Pasture (Pastor). After deliberation and consultation, he having labored with us, and supplied of our desk for a time.

1. Resolved unanimously, to give him a call, provided means can be obtained for his support. Received Sister Abigail Stone by letter LaFayette church dated Jan. 13th, 1846.

2. Resolved that the Deacons be requested to fill up a subscription now out by giving it a full circulation, and if found sufficient, enter into a contract with him and secure his labors as a Pastor. Present 26.

After which the following Brethren and sisters were received by letter from Tully Church, Joel Hiscock & Anna his wife. Letter dated Jan. 20, 1849. Also Alva Wiand & Parly his wife, Nancy Wiand, Jane Ingison, Harriet Sparks, letter dated Tully Jan. 27, 1849. Closed as usual by prayer.

April 7, 1849

Covenant meeting attended, after the usual service the following by letter. Elder Thomas Brown & Laurancy Brown his wife, Mariann Brown & Julia Ann Adams by letter from Marcellus church dated March 24, 1849. Also Polly Clerk from Tully church dated Mar. 17, 1849. Also Abigail Van Patten upon experience. Closed by prayer.

April 8, 1849

After sermon, received James Smith, Catharine Smith, and Betsy Smith by letter from Tully church, after which the Lords Supper was administered. With our hearts we could say, Blessed Jesus what delicious fare, how sweet thy entertainments and never did Angels taste above, redeeming grace and dying love.

May 12, 1849

Monthly meeting at the church, agreeable to appointment. Called to order by Elder T. Brown. Prayer by Br. H. Rowland. Covenant read by Eld. T. Brown and instruction given, after which Brethren and Sisters related the exercises of their minds. The Holy Spirit seemed to shed down his divine influence, and a heavenly union was happily enjoyed. Sister Lemira Darrow then presented herself as a candidate for membership with us, and gave a relation of her Christian experience, her present feelings and resolutions. Where upon it was unanimously resolved that she be received into fellowship, as a member with us. She having been previously Baptized. Eld. Brown then gave her the hand of fellowship with Christian admonition and council

Then after some consultation resolved that a committee be appointed to ask for and secure our just claim and right to the parsonage house and lot at Tully Center as set forth in certain resolutions passed by the Baptist Church & Society at Tully.

Resolved said committee consist of three, (Viz) Deacons Josiah Daniels, and U. Smith & Br. E. V. P. French. Closed by prayer. (16)

June 9, 1849

Church met in covenant meeting. Opened by prayer by Eld. T. Brown. After reading the covenant by Eld. Brown, the Brethren and Sisters expressed their religious feelings exercercises of mind renew covenant, and travil (travel) forward in the ordinances of Christs house. Present 20. Then called on the committee appointed to engage Eld. T. Brown as our Pastor. Whereupon the committee reported their engagement with Eld. T. Brown to labor as Pastor of the church for one year commencing the first day of March last. Report in writing reference had to that in the hands of the clerk. Report accepted and adopted. Closed by prayer.

June 10, 1849 Sabbath

After sermon and the usual service of the day, the church took their seats around the Lords Table. A solemn and interesting time all could adopt the language of the poet and say. Far from my thoughts vain world be gone. Let my religious hours alone. Feign would my eyes my Savior see. I wait a visit Lord from Thee.

Prayed by God the visit was enjoyed. Present 27

July 7, 1849 Saturday

Monthly covenant meeting of the church. Opened by prayer and reading the covenants and an interchange of feelings and views of Brethren & Sisters. A happy state of feeling manifest so that at the close we could unite and sing. From whence doth this union arise.

Sister Eliza Parmer received upon experience having before been baptized.

Closed by prayer. Present 20

August 11, 1849

Covenant meeting attended as usual. Eld. Brown present, taking the load of the exercises of the meeting as he always has been faithful to do since he became our Pastor. The way was clear to go forward to the ordinance of the Supper. Sister Lucretia Smith was received by letter from Spafford church dated June 9, 1849.

Closed by prayer. Present 23.

August 12, 1849 Sabbath

After preaching and the usual religious services the church went forward to the communion supper. It was a solemn (solemn) and interesting time in view of the symbols (symbols) of the Death and Sufferings of Christ. We could say, Come Saints and drop a tear or two. Here love and grief beyond degree. For him who groaned beneath your load. The Lord of Glory dies for men. A thousand drops of richest blood. Jesus the dead revives again.

Present 32.

Sept. 8, 1849

According to appointment church met in covenant meeting. A good season, love and harmony prevailing. At the close of the usual services, after some consultation it was:

Resolved that we represent ourselves by letter and delegates to the Onondaga Baptist Association, for the purpose of becoming a member of that body. Resolved that Eld. T. Brown & Deacons, U. Smith, J. Daniels, Br. P. Henderson & J. Hiscock be our delegates. Present 21.

Sept. 16, 1849 Sabbath

After sermon Almon Carr & Avantha his wife & Emeline Hubbard were received into fellowship as members of the church by letter from Tully church, dated Sept. 1st and 15th, 1849.

Oct. 13, 1849 Saturday

Covenant meeting of the church. Attended with good feelings, enjoying the unity of the spirit. Believing Christ at their helm, the way clear to go forward. The meeting conducted as usual. Present 18

Oct. 14, 1849 Sabbath

Went forward to the communion supper. Present 29.

Nov. 10, 1849 Saturday

Monthly covenant meeting attended by the church. Nothing special to be noted. Present 15.

Dec. 8, 1849 Saturday

Covenant meeting. After the Brethren & Sisters spoke their minds Susan Henderson related her Christian experience, offering herself as a candidate for the ordinance of Baptism and a member of the church after which resolved that she be received as a candidate for the ordinance of Baptism and when Baptized, a member with us. Present 30.

Dec. 9, 1849 Sunday

After sermon Sister Hannah Haynes was received by letter from LaFayette church, dated June 13th, 1846. Present 33.

The supper was administered with deep interest of feeling. Many if not all could sing with the

Jan. 12, 1850 Saturday

Monthly covenant meeting attended. Opened as usual. Present 17. A happy state of feelings in the minds of the Brethren & Sisters present. Closed by prayer.

And now dear Brethren as the first year of our visibility as a Church of Christ closes up, and a new year about to commence, it is proper to look back and review the past mercies, and speak of the goodness of God. When we commenced a year ago, we could say with the prophet of old, "By whom shall Jacob arise for he is small," but God seemed (seemed) to speak so clearly by His providence, we could not mistake, saying "Arise and build" raise the standard of the cross in Vesper, we obeyed the divine injunction, trusting in God as our leader; We felt our weakness, and inability to carry forward so great a work, as to raise the blood stained banner of the cross in Vesper, and defend the glory of His Great Name. Our resources small, our members 25, But God who is rich in mercy said, "Fear not little flock for it is your Fathers good pleasure to give you the Kingdom." We took courage and launched forth and blessed be His great and Holy name. He has reached forth his arm of mercy and sustained us.. The eye of the compassionate Jesus was upon us and seemed to say to his servant Eld. Thomas Brown, "Go feed my sheep at Vesper". The bowels of a Saviors love moved his heart, he obeyed and came, and at our request commenced his labors and became our Pastor the first of March last. His labors have been blessed, the church have been edified and built up under his ministry. He has faithfully preached the Word, warning sinners day and night with tears. There has been a gradual increase of numbers, by letter and experience, until we now number 48, and one received as a candidate for the ordinance of Baptism and membership, and one with his letter ready to join, which when performed will double our number; not withstanding we are under the painful necessity of the recording the death of our beloved Sister Muriah Rowland, who was called suddenly from the church militant to the church triumphant, her seat is empty in this house forever. Her exhortations and prayers we shall hear no more on earth, but the apostle admonishes us, not to mourn as those who have no hope, for all they who sleep in Jesus, will God bring with Him, therefore comfort one another with these words.

We have to say the Lord has blessed us with the unity of the spirit, so that we have had no labors to attend to but those of love. We have been enabled to sustain an interesting Bible class and Sabbath School. The latter through the summer. The weekly prayer meeting has been sustained by a few who have mourned and wept, and wrestled in prayer for a blessing of Divine grace to be poured fourth. The monthly concert prayer meeting has been observed with deep feeling and anxiety for the spread of the gospel, and the salvation of souls, and the Lord has graciously heard, and His Holy spirit is poured forth in our midst. Prodigals are returning, backsliders reclaimed and sinners being pricked in their hearts, and saying men and brethren what shall we do to be saved, and some we trust have had their feet taken out of the horrible pit and miry clay, and placed upon the rock Lord Jesus, with the new song put in their mouths, saying Glory to God, for He hath spoke peace and pardon to my sole.

The semi-annual meeting of the Onondaga Baptist Association sat with us on the 29th, result a very precious season. Elder Bates of Canton has remained laboring with our Pastor in a protracted effort, for the promotion for the Glory of God, and the salvation of souls in this place, and the blessing of Him rests upon their their united labors connected with the church for God is in Christ, reconciling sinners to Himself, through the instrumentality of the preached Word, and the prayer and exhortations of His people.

Now dear Brethren, in conclusion we should say with one of old, what hath God wrought, surely we have reason to bow before Him in love, and gratitude, for His great love wherewith He hath loved us, in washing us and cleansing us from our sins, and using us as instruments in His hands, for the promotion of His glory. Let us keep near the cross, stript for the race, harnessed for the battle, humbly imploring His blessings to be continued, and His protecting arm be as a wall of fire round about us, and the glory in the

midst of us, that we might soon witness such an outpouring of His Holy Spirit, that Lions gates shall be thronged with willing converts, filling His earthly courts with songs of praise, and the year to come tell more for the Glory of God, in the rich displays of His grace, producing more and deeper piety in the church and the salvation of souls than the year past.

Feb. 5, 1850

Annual church meeting convened at the Baptist meeting house in Vesper pursuant to adjournment. Eld. T. Brown was present as chairman. Prayer by Dea. U. Smith

1. The clerk was called upon to read the records of the past year, whereupon the clerk proceeded to read the records, connected with the historical introductory remarks with the closing summary address.

2. Resolved unanimously that the records as read, connected with the introductory remarks and closing summary address be adopted and approved.

3. Resolved that Dea. U. Smith serve as clerk the ensuing year.

4. Resolved that our treasurers report be suspended until our monthly meeting in March.

5. Resolved that Deacons circulate a subscription to raise funds to support our Pastor for the ensuing year.

6. Resolved that this meeting stand adjourned until the first Tuesday of February next at 1 o'clock P.M. at this place. Closed by Prayer by the chairman.

Feb. 9, 1850 Saturday

Church met in covenant meeting. Prayer by Dea. U. Smith.

Articles of Faith and Covenant read by our Pastor, after which the Brethren and Sisters expressed their feelings and exorcise of mind. A very happy state of feeling manifested with deep anxiety for the salvation of souls. Opportunity was then given for others to speak in the cause of the Blessed Redeemer. Alfred J. Smith was then received by letter from the Tully church dated Dec. 31, 1848. The following persons then related their Christian experience, desiring to be baptized and added to the church (to wit) Elisha Darrow, Emily S. Smith & Asa Ransom. Received unanimously one by one, they be received to the ordinance of baptism and when baptized in fellowship with us as members. A number more present spoke of the joys of their souls. Closed with prayer by the Pastor. Present 25.

Surely we could sing:

Earth here engrossed to (too) long
Tis time I lift mine eyes,
Upward Dear Father to thy throne,
And to my native skies.

There the Blessed Man my Savior sits,
The God how bright He shined
And scatters infinite delight,
On all the happy minds.

Feb. 10, 1850

Sabbath. After the A.M. service retired to the water, and then our Pastor baptized Elisha Darrow, Asa Ransom & Emily S. Smith, in the presence of a large and attentive congregation. During the service the church sang "How happy are they who their Savior obey". We then came back to the meeting house, and the congregation seated and meeting commenced. A sudden alarm was given that Br. Allen Parmer's house was on fire. There was a rush at the doors, when shocking to behold volums (volumes) of smoke was issuing from the house and through the roof. Many sleighs at hand were loaded with men eager for the rescue, being drove with the greatest speed it being a little over ½ of a mile. With _____ of labor the house was saved, by the blessing of God, although considerably damaged. Such was the excitement and necessary scattering of the congregation that the Pastor with advice of his Brethren, dismissed the remaining part of the assembly and postponed the ordinance of the supper until next Sabbath. The providence of God in this instance was verry (very) striking. It reminds us of that great day when the heavens shall be rolled together

as a scroll and the elements shall melt with fervent heat. May we all be prepared for that great day.

During the week the church continued their protracted effort by holding meetings evenings and part of the time afternoons. Eld. Bates continued with us to labor and preach with our Pastor, and the Lord continued to bless. A number hopefully converted to God, and others saying prayers for us.

Feb. 16, 1850 Saturday

Sister Mary Aylsworth was received by letter from Fabius church dated Jan. 5th, 1850.

Feb. 17, 1850 Sabbath

Prayer meeting 9 ½ (9:30) A.M. 10 ½ (10:30) Eld. Bates preached a short _____ then prayer meeting after that Eld. Brown our Pastor preached, after which the ordinance of the Lord's Supper was administered. Agreeable to the pattern given they sang a hymn and went out. Having appointed to continue the protracted effort by holding meetings during the week.

Feb. 23, 1850 Saturday

The following were received upon experience for the ordinance of baptism and church membership when baptized.

Lorenzo Beach - Delight Beach - Harriet Beach - Sally Stone - N. B. Harriet Beach was received by experience Sabbath before sermon.

During intermission at noon the above named were immersed by our Pastor in the presence of a large concourse of people. Love constrains us all to follow Jesus to His grave.

Mar. 2, 1850 Saturday

Saturday P.M. church conference held at the meeting house, at the close of which Laura Daniels was received into fellowship as a member of the church upon the relation of her Christian experience having been previously baptized. Also Alfred B. Daniels, Wealthy Ann Bishop and Francis Carr were received with experience as candidates for baptism and church membership when baptized.

Mar. 3, 1850 Sabbath

Alfred B. Daniels and Wealthy Ann bishop were baptized by our Pastor and added to the church.

Mar. 9, 1850 Saturday

Monthly meeting of the church. A very interesting season. Union and the love of God abounding. Dea. Aaron Van Antwerp & Delatice, his wife, were received as members of the church upon letters from Spafford church dated Feb. 17th. 1850.

Apr. 13, 1850 Saturday

Covenant meeting attended as usual. A good state of feeling manifested. The solemn providence of God in the death of Sister Laura King of Tully was feelingly noticed, so sudden an awful being thrown from her waggon (wagon) and very much bruised and mangled causing her death. Our Pastor being requested to preach the funeral sermon tomorrow. Therefore our meeting was adjourned until next Saturday and the ordinance of the Supper until next Sabbath one week. Present 32

Apr. 20, 1850 Saturday

Met agreeable to adjournment. A verry comfortable time. After speaking their minds, Marietta Rowland was received upon experience as member of the church having previously been baptized.

Apr. 21, 1850 Sabbath

Church went forward to communion. Present 43

May 11, 1850

Monthly meeting attended as usual. A comfortable time, nothing material worthy of record. About 30 present.

Jun. 8, 1850 Saturday

Church met in covenant meeting. A verry good season. The next day went forward to the communion table.

Jul. 7, 1850 Sabbath

Resolved , Sister Lucretia Smith have a letter of dismission & recommendation.

Jul. 13, 1850 Saturday

Monthly meeting, attended. As usual a good degree of union in the body yet some trials. Two Brothers had backslidden, once confession accepted and the Br. forgiven. Br. Ira Ransom not satisfactory. Thought best to give time for labor and further investigation - therefore - Resolved we hold a special church meeting the 20th instant, for to examine into and decide on Br. Ira Ransoms at the request of Br. Joel Hiscock & wife, having removed to Syracuse; resolved they have letters of commendation & dismission. Adjourned by prayer.

Jul. 20, 1850

Special church meeting. Opened by prayer. Took up the case of Br. Ira Ransom, and after examination, and prayerful deliberation with the light of evidence before them, unanimously came to the following result; resolved that we have come to the end of labor with Brother A. C. Ransom and do now withdraw the hand, and exclude him from our fellowship, no more to be covented as a member with us, for the following reasons, s. s. For making to (too) free use of ardent spirits, frequenting a reported house of ill fame & breaking the peace, for which he had been tried by the civil authorities, convicted and imprisoned in the county jail for 30 days and for telling falsehoods. Closed by prayer.

Aug. 10, 1850 Saturday

Covenant meeting of the church. The unity of the spirit was enjoyed and the way prepared to go forward. Nothing very special. The next day Sabbath, went forward to the ordinance of the Supper.

Sep. 7, 1850 Saturday

Church met as usual at her monthly meeting. After the usual exercises of prayer and conference, it was resolved to send a letter and a delegation to represent us to the Onondaga Association.. The following Brethren were chosen delegates: to wit. Elder T. Brown, Dea. J. Daniels, Dea. U. Smith, Brother A. Parmer, Brother H. Rowland, Brother E. Darrow.

Covenant meeting preparatory to communion. Attended, union still prevails, we could say, with

the psalmist "Behold how good and pleasant it is for Brethren to dwell together in unity."

Dec. 8, 1850 Sabbath

Elder Brown being called away to attend a funeral, Eld. Gardner came and presented and broke bread to the church.

1851

Jan. 11, 1851

Monthly meeting attended as usual. A solemn gloom seemed to rest down upon the church in that we have to record the death of Sister Cibbil Smith who died on the 3rd. Our beloved Sister had left the church militant and we believe through faith in our Lord Jesus Christ has joined the church triumphant, the gloom was somewhat removed by the Holy Spirit. Influence being felt to comfort and console. May the Lord sanctify and still bless His people. Closed by prayer as usual.

Feb. 4, 1851

Annual church meeting held at the meeting house 1 o'clock p.m. agreeable to adjournment.

1. Opened by prayer by our Pastor Eld. T. Brown.
2. Called for the reading of the records of the past year. Accepted and adopted. Also for the reading of a summary & condensed report prepared by the clerk. Accepted and adopted and ordered to be placed on the record as follows. To wit.

Report:

Dear Brethren:

As another year of our visibility has closed up, and a new commences, it is proper to review the past, and call to mind the goodness of God, in His rich mercy towards us, in that we have been kept in the unity of the spirit & bond of peace.

The year past commenced with us, with glorious prospects. The Lord was a pouring out of His spirit, souls were being converted, while saints rejoiced, sinners trembled, and the Lord added to the church a number of such as we expect will finally walk with Him in white. We have also been blessed with the labors of our beloved Pastor Eld. T. Brown, by whose ministry the gospel has been faithfully preached and the ordinances administered. But God in infinite wisdom has permitted the Angel of Death to strike the fatal blow. A Mother in Israel is fallen. Sister Cibbil Smith is gone. She met in this house with the church militant for the last time the last Sabbath in Nov., and the 3rd day of Jan. 1851 her happy spirit took its flight to join the church triumphant. Her seat is empty, her prayers and exhortations ended in this house forever. Oh! that God will pour the consolations of the gospel into the wounded heart of our bereaved Brother & family & sanctify this solemn providence to us all.

We have reason to bless God, not withstanding this sore bereavement, He has blessed us in general with health in our families and increased our numbers, having added to us 9 by baptism, 6 by letter & 1 by exp, so that not withstanding we have dismissed 4 by letter, ex. 1, died 1, we have increased 10. You will learn from the treasurers report with regard to our financial concerns. We would say also that our Sabbath school conducted by A. Parmer through the summer, became very interesting. Also the Bible class by our Pastor, and the weekly prayer meetings and monthly concert, has been sustained by a few Brethren & Sisters, who have got down at the foot of the cross and so up to the mercy seat, and have come back singing: When I go to heavens store,

Asking for a little more,
Jesus gives a double share,
Calling me a gleaner there.
Then I go rejoicing home.
From the banquet of perfume,
Gleaning many on the road,
Dropping from the word of God.

Finally dear Brethren, let us humble ourselves under the mighty hand of God, endeavoring to _____ the time, by keeping the unity of the spirit, each one esteeming others better than themselves, always ready to discharge our dutys, both public & private, with fidelity, praying always for the guidance of the Holy Spirit, to enable us to add to our faith, virtue, and to virtue, knowledge, so that when we have done laboring here, an abundant entrance may be administered unto us, into the everlasting Kingdom of our Lord and

Saviour Jesus Christ.

Resolved that when this meeting adjourn it be until next Saturday Dec. 17th at 2 o'clock P.M. in this place to hear such report & transact such other business as comes before the meeting. The matter of caring for the meeting house ringing bell was discussed and action deferred to the meeting next Saturday.

After reading the notice of meeting stating its object and purpose, a motion was carried that we elect three members according to law as a Board of Trustees. A ballot was taken electing Bro. Josiah R. Daniels, Bro. Frank Hodge and Dea. Alfred J. Smith. The trustees thus elected then drew lots for their terms of service. Brother Josiah Daniels drew for one year. Bro. Frank Hodge drew for three years, and Dea. Alfred J. Smith for two years.

Jun. 12, 1900

The annual meeting of the Vesper Baptist Church was opened by prayer offered by Deacon A. F. Smith also a chapter was read from the Bible. A. J. Smith acted as chairman for the evening. Brother William H. Sherman was elected trustee for three years. Mrs. A. J. Smith elected church clerk for one year. Lottie Daniels treasurer.

After a lengthy discussion in regard to sexton, it was decided to leave the matter for an after consideration. Minutes of the meeting read and approved. Motion carried that meeting stand adjourned untill first Tuesday evening in June 1901

Sep. 16, 1900

Our pastor presented his resignation from the church to take effect the 7th of October, he having received a call to the pastorate of the First Baptist Church of Harrison, NJ, and accepted it, as it opened to him a much larger field of usefulness.

Nov. 1, 1900

Rev. W. H. Barrett commenced his labors with us as pastor of the Baptist Church, is to receive for services \$100 and what aid can be had from the State Convention.

1901

May 26, 1901

A letter was given Mrs. Etta Brown to unite with the First Baptist Church Cortland, NY.

Jun. 4, 1901

Was held the annual meeting of the Vesper Baptist Church. Opened by reading the scripture also prayer offered by Deacon A. J. Smith. Minutes of the last meeting read and approved, also the record of the church work read. Deacon A. J. Smith elected trustee, Mrs. A. J. Smith church clerk, Lottie Daniels treasurer.

Jul. 21, 1901

After preaching, services conducted by our pastor Mr. Barrett. Miss Hattie Hodge and Miss Lena Strail were baptized and the next Sunday were welcomed into the church with the right hand of fellowship.

Aug. 1901

In August C. E. Barber was received by letter given by the First Baptist Church of Stony York, Pa..

Sep. 1901

In September Mr. Barrett left us to resume evangelistic work, being employed by the State Convention.

Oct. 6, 1901

Rev. D. D. Harmon commenced his labors here as pastor, being engaged for the sum of \$75.00

from the church and \$75.00 from the State Convention.

J. R. Daniels elected trustee for three years. Mrs. A. J. Smith church clerk and Br. Sherman treasurer for the year.

Meeting adjourned to meet the first Tuesday evening in June nineteen hundred three.

Feb. 11, 1903

Josiah R. Daniels died.

Apr. 1, 1903

Our pastor left us to accept a call from a Baptist Church in Moravia.

1904

Jun. 7, 1904

The annual meeting of the Vesper Baptist Church was opened by C. E. Barber reading a chapter from the Bible, after which prayer was offered by W. H. Sherman, after which W. H. Sherman was chosen chairman.

The following officers were elected for the coming year. C. E. Barber was elected trustee for one year to fill vacancy in place of J. R. Daniels. W. H. Sherman was elected trustee for two years. Frank Hodge was elected trustee for three years. Mrs. W. H. Sherman was elected treasurer. Harriet E. Hodge was appointed clerk and C. E. Barber sexton. After which the meeting was adjourned until the first of June 1905.

1915

Oct. 17 & 24, 1915

A notice was read from the pulpit of the Vesper Baptist Church Oct. 17th and Oct. 24th, 1915, calling a meeting to convene in the evening of Oct. 24th to consider the question of uniting the membership with the First Baptist Church of Tully, also to vote the property to the same.

Meeting convened and adjourned till Saturday night Oct. 30th at the home of Frank Hodge at which time the church gathered, all trustees being present.

Meeting called to order by the pastor Rev. B. R. Smith. A motion was made by Frank Hodge and seconded by Mr. Wm. Sherman that the present membership of the Vesper Baptist Church unite and

become a part of the First Baptist Church of Tully, NY. And that the property both real and personal be transferred to said church. This motion was unanimously carried. Motion was then made that we adjourn till the evening of the 20th day of November.

Deacon Alfred J. Smith died.

Mrs. Mary Daniels died March 1st, 1913

Mrs. Jannette Carr died May 7th, 1915
